CONTRACT

The undersigned, as parent(s)/guardian(s) of a student of Yavneh Academy of Dallas, accept the following items:

1. It is understood that enrollment at Yavneh Academy of Dallas is conditional upon the maintenance of satisfactory performance in both Judaic and General Studies courses and upon payment of tuition and fees in accordance with the payment schedule set forth by the Yavneh Academy of Dallas Board of Directors and/or its authorized representatives.
2. Registration of any student is not complete, and a student may not attend classes at Yavneh Academy of Dallas, until all applicable fees have been paid and authorized arrangements have been made through FACTS Tuition Management for tuition payment. Note: Registration fees are non-refundable.
3. Tuition is payable in the following ways:
 - A. Full payment by June 1, 2006
 - B. Semi-annual payments contracted through FACTS Tuition Management where half is automatically deducted from your bank account in June 2006 and the other half is deducted in December, 2006
 - C. Ten monthly installments contracted through FACTS Tuition Management where monthly payments will be automatically deducted from your bank account starting June, 2006 and ending in March, 2007
 - D. Parents applying for financial assistance must return their forms by February 17, 2006. Once approved, their monthly payments will be contracted through FACTS Tuition Management in 10 monthly payments which will be automatically deducted from your bank account starting June, 2006.
4. Because of the commitments made by the school for teachers and other expenses, the obligation to pay the full amount of annual tuition, on the terms stated in Number 3 (above), is fixed on the signing of this contract, regardless of withdrawal from school for any reason.
5. A non-refundable registration fee of \$200 per student is due with the application. The registration fee for applications received prior to March 1, 2006, is \$200 per student; after March 1, 2006, the fee is \$300 per student; after May 15, 2006, the late registration fee is \$500 per student.
6. Discounts: Tuition paid in full by March 31, 2006 two percent
7. A mandatory \$1000 per family building fund fee (tax deductible) is due at the time tuition is paid or arrangements with FACTS are made.
8. Final acceptance of new applicants by Yavneh Academy of Dallas is subject to a review by the Admissions Committee.
9. Students school records are released only if there is no outstanding indebtedness to the school.
